

A RESOLUTION SUPPORTING THE INSTALLATION OF A TRAFFIC SIGNAL ON WALKUP AVENUE AT PRAIRIE RIDGE HIGH SCHOOL

WHEREAS, the Town Board of Trustees (the "Board") of Nunda Township support traffic improvements which foster safe vehicular travel and protect pedestrians and other users along public ways; and

WHEREAS, traffic conditions along Walkup Road at the entrance of Prairie Ridge High School present safety concerns to motorists, bicyclists, pedestrians, and other users on Walkup Road and Dovorak Drive; and

WHEREAS, the Prairie Ridge High School driveway (known as Dovorak Drive) to Walkup Road, serves the Township, its residents, and the general public; and

WHEREAS, to ensure the safety of the traveling public, of the students attending
Prairie Ridge High School, as well as the faculty, parents and vendors, and those using Walkup
Road, at the intersection of Prairie Ridge High School and Walkup Road, the Board believes that
it is in the best interests of the traveling public to have a traffic signal installed on Walkup Road
at the entrance of Prairie Ridge High School; and

WHEREAS, a traffic light will provide safe and controlled access to and egress from Prairie Ridge High School, and improve the traffic flow on Walkup Road; and

WHEREAS, The Board hereby encourages the County to pursue all reasonable opportunities to cause a traffic signal to be installed on Walkup Road at the entrance of Prairie Ridge High School; and

WHEREAS, the Board on behalf of the residents of Nunda Township hereby supports the installation of a traffic signal on Walkup Road at the entrance of Prairie Ridge High School;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF TRUSTEES OF NUNDA TOWNSHIP, as follows:

SECTION ONE: RECITALS, the Foregoing recitals are incorporated in and made a part of this Resolution by this reference; and

SECTION TWO: SUPPORT FOR TRAFFIC SIGNAL. For the reasons set forth in this Resolution, the Nunda Township Board of Trustees hereby support the installation of a traffic signal on Walkup Road at the entrance of Prairie Ridge High School. Further, the Board encourages the McHenry County Board and its Division of Transportation to take all reasonable measures to cause the installation of a traffic signal on Walkup Road at the entrance of Prairie Ridge High School.
