Public Comment: Trish Meyers – South Street, Burtons Bridge subdivision – Thanked the Board for everything they do for the community and expressed her frustrations with the road/drainage construction being done on South St., Johnson St. and Illinois St. in Burtons Bridge subdivision. Mrs. Meyer's stated her concerns included not being notified ahead of time that road/drainage work was to be done in the area, the height of the newly paved road could possible cause water run off into her driveway and cone covered raised manholes in roads during construction could cause issues for emergency vehicles on the roads while construction is being done.

Trustee Tim Parrish – Apologized to the Board for missing the previous months meeting. Trustee Parrish stated for the record that this was the first meeting he missed in five years. His absence was due to a last-minute JV League Basket Ball game he was called to Coach, as this is a paid Coaching position therefore his absence for the Board meeting was unavoidable.
