#### **ORDINANCE NO. 02-13-25-01**

# AN ORDINANCE ABATING A PORTION OF THE ANNUAL TOWN GENERAL ASSISTANCE FUND TAX HERETOFORE LEVIED FOR THE FISCAL YEAR BEGINNING APRIL 1, 2025 AND ENDING MARCH 31, 2026 UPON ALL TAXABLE PROPERTY IN NUNDA TOWNSHIP

WHEREAS, the Town Board of Trustees (the "Board") of Nunda Township, McHenry County, Illinois (the "Township"), by Ordinance adopted on December 12, 2024 (the "Levy Ordinance"), did provide for the levy of a direct annual tax in the amount of \$32,000.00;

WHEREAS, the Board hereby determines that there are sufficient funds available and/or will otherwise be levied for the Annual Town General Assistance Fund;

WHEREAS, the Board of the Township finds that it is necessary and in the best interests of the Township that the amount of \$32,000.00 of tax heretofore levied for the year April 1, 2025 to March 31, 2026 for the Annual Town General Assistance Fund be abated so that the amount levied is reduced to \$0.

NOW, THEREFORE, Be It and It is Hereby Ordained by the Nunda Township Board McHenry County, Illinois, as follows:

Section 1. Incorporation. The above-stated recitals are incorporated by this reference.

Section 2: Abatement of Tax. The amount of \$32,000.00 of the tax heretofore levied for the year beginning April 1, 2025 and ending March 31, 2026 is hereby abated so that the final amount of the Annual Town General Assistance Fund Levy is reduced to \$0.

Section 3. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the Town Clerk shall file a certified copy hereof with the County Clerk of McHenry County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2025-2026 in accordance with the provisions hereof.
