**A RESOLUTION AUTHORIZING MULTIPLE METHODS OF CLERK
ATTESTATION FOR TOWNSHIP PAYOUTS**

WHEREAS, Section 70-27 of the Illinois Township Code (60 ILCS 1/70-27) requires the township clerk to attest to payouts issued by the township supervisor; and

WHEREAS, the Illinois Electronic Commerce Security Act (ECSA) and the federal ESIGN Act permit the use of electronic signatures for legally binding transactions; and

WHEREAS, the Township Board seeks to provide flexibility in attestation methods while maintaining compliance and transparency;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Nunda Township, McHenry County, Illinois, as follows:

SECTION ONE: AUTHORIZATION

The Township Clerk is hereby authorized to attest to payouts issued by the Township Supervisor using any of the following methods:

1. Physical Signature: Handwritten signature on checks or payout documents.
2. Electronic Signature: Applied through a secure platform (e.g., Adobe Sign) compliant with ECSA and ESIGN Act.
3. Digital Signature: Cryptographically secure signature using digital certificates.
4. Stamped or Facsimile Signature: Rubber stamp or printed signature, provided clerk has authorized its use in writing and documentation exists in meeting minutes or separate authorization.
5. Alternative Attestation Methods: Clerk attests via check register, board meeting minutes, or email confirmation attached to payout documentation.

SECTION TWO: COMPLIANCE REQUIREMENTS

All records generated under this Resolution shall be retained in accordance with the Township's retention schedule as approved by the Local Records Commission under the

Local Records Act (50 ILCS 205). No public record may be destroyed without an approved Records Disposal Certificate. Emergency financial assistance payouts under Section 6-10 of the Illinois Public Aid Code remain exempt from attestation.

If the Township provides financial processing assistance to the Road District, the Clerk's attestation rules in this Resolution shall be applied in a manner consistent with the Illinois Highway Code's payout-attestation requirements.

SECTION THREE: REVIEW AND VERIFICATION

All attestations made pursuant to this Resolution shall be presented to the Board for review and verification at its next regularly scheduled meeting and recorded in the official minutes.

SECTION FOUR: EFFECTIVE DATE

This Resolution shall take effect immediately upon adoption and remain in force until rescinded or amended by the Board.
