## **ORDINANCE NO. 2025-12-11-01-01**

### **Supplemental Budget and Appropriation Ordinance for the Permanent Hard Road Fund for Fiscal Year 2025–2026**

WHEREAS, the Nunda Township Road District adopted its Annual Budget and Appropriation Ordinance for the Permanent Hard Road Fund for fiscal year April 1, 2025, through March 31, 2026;

WHEREAS, additional revenues and expenditures have been identified that were not anticipated at the time of adoption;

WHEREAS, pursuant to 60 ILCS 1/80-50 and applicable law, the Road District desires to amend its Budget and Appropriation Ordinance accordingly;

NOW, THEREFORE, BE IT ORDAINED by the Highway Commissioner of the Nunda Township Road District, McHenry County, Illinois, as follows:

#### **SECTION 1. Amendment**

The Budget and Appropriation Ordinance for the Permanent Hard Road Fund is hereby supplemented and amended as follows:

### **SECTION 4. Repealer**

All ordinances in conflict herewith are repealed to the extent of such conflict.

### **SECTION 5. Effective Date**

This Ordinance shall be in full force and effect upon passage and approval as provided by law.
