**TRANSFER OF APPROPRIATION FOR THE NUNDA TOWNSHIP
ROAD DISTRICT**

WHEREAS there was adopted on the 8th day of May, 2025 by the Board of Trustees of Nunda Township, McHenry County, Illinois a Budget & Appropriation Ordinance for the fiscal year beginning April 1, 2025 and ending March 31, 2026, and

WHEREAS it now appears that certain adjustments between appropriated line items in the Permanent Hard Road Fund in said ordinance are desirable and necessary, and

WHEREAS Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3), as approved July 12, 1937, as amended, authorizes transfers between the various line items within any fund in such appropriation ordinance not exceeding 10% of the total amount appropriated in such fund by such ordinance, now therefore

BE IT RESOLVED by the Board of Trustees of Nunda Township, McHenry County, Illinois.

That there is hereby transferred from the unexpended balance of the line item Road Improvement (400-170-642) in the Permanent Hard Road Fund the sum of twelve thousand dollars and 00/100 Dollars (\$12,000.00), which transferred sum is hereby added to the line item Maintenance/Facility Improvements (400-200-634) in the same fund.

Additionally, there is hereby transferred from the unexpended balance of the line item Maintenance & Repairs (400-190-626) the sum of thirty-three thousand dollars and 00/100 Dollars (\$33,000.00), which transferred sum is hereby added to the line item Health Insurance (400-120-676) in the same fund.

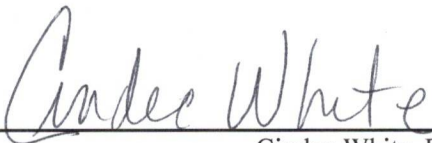

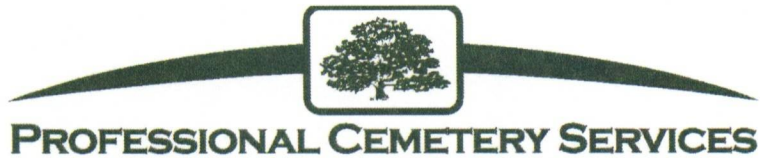
